The Woodward-Granger Community School District Board of Education met in a Regular Meeting on Monday, September 13, 2021. The meeting started at 6:00 p.m. in the Gym of the Grandwood Education Center in Granger, Iowa.

**Approval of Agenda:** Sam Behrens moved and Tim Bogardus seconded the motion that the WG Board of Education approve the agenda for the Regular Meeting and Board Work session for Monday, September 13, 2021 as presented. The motion carried 5-0.

**Communication from the Public:** Kristi Bilbrey shared information from the WGEA. They have been checking in with the new teachers. WGEA has also been working on the recertification with PERB. They are working on inventive ways to inform the staff on the importance of voting for the recertification. The first labor management meeting is this Thursday and they are excited to get back into the book study. Jill Lehmann-Bauer shared her concerns about the mask limitations and public health for our school. She had submitted a request on 7/19/21 to the board to denounce violence in the rhetoric of Qanon in which she has been tracking for some time. She stated that the community and school board need to come together as we ask ourselves who we want to be and how we want to stick up for kids as the pandemic did not end. She had personal experience with her own kids and medical conditions and what has happened is personal, frustrating and furious. This propaganda is coming from the council of national policy, the John Birch Society, The American Legislative Council, and the Cato Institute. She encourages all to read the book The Shadow Network by Ann Nelson. She is speaking with 2 direct questions now that the mask mandate has an injunction, what's your position as a school board to stand up for kids. Secondly a statement denouncing violence from Qanon, denouncing the NRA and part of who is funding this. She stated we have a responsibility to stand up against mis and dis information in the Great Barrington Declaration. She asked that each of the Board members have a position regarding the kids and the safety and the health of them. She doesn't want to go through this again with her kids and doesn't believe that we are acting in good faith if we do not stand up now. President Brandt appreciated the comments. She stated that the board is not in a position yet to release a stance on the mask mandate yet. The board and Administration will review and follow guidance of the medical professionals. Jill asked for a time frame and if two weeks is too long? Kim Nyborg stated that the mask mandate was erased within hours of her signing it. President Brandt committed to reviewing it. Sarah Watt showed her support stating that time is of the essence and the longer we wait the more chance the kids could get sick.

Bella Coffin, Keilayla Gregory, and Ella Bearbower have been working on updates to the dress code. They have been researching Roosevelt and DCG schools dress codes who recently updated. She has been looking at the good and bad. Some of their focuses are culturally sensitive clothing, biases towards certain students, homophobic sayings, gender biased clothing, and hats/head dresses. They are looking to get rid of more of the grey area because there's too much confusion. They are still early in their research. The board encouraged them to keep up the work and keep working with the administration to make the changes.
